Here we will address some common issues and Stuard's approach to those issues. As Elevator Professionals that have been in the industry for 30-50+ years, we have seen a world of changes not only in equipment, but Elevator Contractor's installation and maintenance practices. In the old days when hoistways and escalator trusses underwent an annual clean down, and many heavily used units required weekly maintenance that was completed no matter the time it took. However, today's mechanics are scheduled through GPS systems on their phones with a set time allowance for each job. This requires them to move to the next job, regardless of what is left to be completed. To be fair, manufacturers have made significant strides in providing equipment made that does not require the old grease gun, oil can, and constant controller contact adjustments; however, sometimes this is still necessary.

As Consultants for Ball State Unviersity, we would recognize these changes in the industry and are equipped to analyze any age of elevator system. This allows us to determine what changes are necessary during a major alteration to provide the BSU with a "new" 25 to 30-year life cycle.

This begins with our initial survey at your location, we will review machine room and owner kept service logs, repair orders, invoices for "extra" charges during the past 12 months, provided such records can/will made available. A meeting will be scheduled with BSU representatives and/or employees who have had direct knowledge of elevator service agreement administration. After the work above is completed, BSU will receive a comprehensive report that will not only fully recommend the extent of each alteration necessary but prioritizes each location by needs AND use by the owner.
